Wild Photo Contest for Middle School Students

Teacher may submit entries on behalf of students based on the guidelines below. A panel of expert judges will choose three final winners and 10 honorable mention winning entries. (Top three winners and their schools will receive prizes. Honorable Mention winners will receive prizes as well.)



GUIDELINES:

- 1) All photos must be taken at Zoo Miami. Get a free student admission pass to Zoo Miami (valid February 1st through March 1st) from your teacher or school coordinator.
- 2) All photos must include at least one animal.
- 3) All photos must be the original work of the student. No reproductions of existing photos, copyrighted materials, or the work of others may be submitted.
- 4) All photo entries must include a title that reflects the artistic composition of the subject matter.
- 5) All entries must be accompanied by a Consent & Photo Transfer Authorization Form that is signed by a parent or guardian, with a Student Entry Form. (Forms are included in this packet and available at www.zoolens.com.)
- 6) You may enter only one photo.
- 7) An expert panel of judges will select winners based on artistic and technical merit, composition and how the title captures the essence of the photo.

Your school will provide you with information on how to submit photos or you may visit www.zoolens.com.

All photos that meet the guidelines above will be assigned an arbitrary ID for judging.
